

The vessel was inspected on its trailer and ran on a water hose only to verify engine function, no sea trial was performed. Vessels lights and accessories were powered on to verify function only. The main engine ran well and changed gears as designed while running on the hose. All navigation and accessory lighting functioned at time of inspection as did the stereo and speakers. The vessel and the trailer are in overall good condition and have been maintained as needed and should be considered in the top range of its retail market value.
